Cost

Learn to Skate/Basic Skills cast in 1st half group only: \$225 (\$150 at registration and \$75 due 1/15/24)

USFS Skaters cast in 1st and 2nd halves of the show (2 groups): \$350 (\$150 at registration and \$200 due 1/15/24)

USFS Skaters cast in a group and as a named character: \$400 (\$150 at registration and \$250 due 1/15/24)

Optional Fees:

Adult Skater Only registration for USFS tested skaters in dance and/or free skater - \$75

Parent/Skater Number: \$30 (includes show T-shirt used for performances)

Show Cancellation Policy

During normal show production, a non-refundable deposit is required at the time of registration.

This non-refundable deposit represents a portion of the entire show fee. All final balances must be paid in full by January 15, 2024.

- a. Payment is collected by PayPal online.
- b. Payment may be accepted by personal check if arrangements have been made with our show treasurer PRIOR to Audition Day (October 28, 2023).
- c. If the Show is cancelled PRIOR to Audition Day (October 28, 2023) -100% of show deposit will be refunded.
- d. If the Show is cancelled AFTER Audition Day (after October 28, 2023)
 -50% of show deposit will be refunded. This is because casting takes place immediately after Audition Day and costume order is placed promptly after that date. Portion of the deposit money is used for marketing, setting up facility contracts and paying director fees.
- e. If the Show is cancelled any time after November 11, 2023 20% of show registration fees will be refunded.

REGISTRATION GUIDE

Please take the time to read all the information prior to registering for our 2024 production.

Information in these documents will answer many of your questions and assist with your early planning for the show. We look forward to working with our returning show skaters and we can't wait to meet our new skater families!

Showtime on Ice operates on these principles:

- Respect Showtime on Ice is a privilege for all skaters to participate in. With great numbers of skaters in each production it is expected that each skater will respect each other, all directors, choreographers, junior choreographers, committee members, volunteers, rink staff and any other person associated with the show.
- Effort It is expected that all participants of the show be committed to rehearsals, choreography, and costume care. Hard work pays off and our end result is always a shining example of the effort our skaters give throughout the process.
- ✓ Attitude What makes a great show? Great attitudes! Showtime on Ice is a fun and exciting event for all and great attitudes make a great show. Please come to rehearsals with the understanding that each skater cast in the show contributes to the story. Come to rehearsals with smiles, a willingness to help each other at every level and to work cohesively as a team.
- ZERO Tolerance Policy In order to foster a safe environment for everyone involved with Showtime on Ice we will be enforcing a strict zero tolerance policy that will include but is not limited to, bullying, physical/sexual misconduct, disrespectful behavior, gossip/rumors and failure to follow required USFS SkateSafe and SafeSport and posted Code of Conduct rules and guidelines. This policy extends to skaters, parents and all others involved with the production side of our show.

Casting – UPDATED FOR 2024

We cast our show immediately after auditions. The casting committee includes the Directors, Casting Coaches, Committee chairs and, at times, club President or other club representatives. Please read important casting items below. *Please note – we have had moments in show history where we had a very large number of Intermediate (Now Pre-Silver) through Senior (Now Gold) level skaters. In a perfect show, we would cast every high-level skater in a character role but that is not always possible.*

Showtime on Ice reserves the right to cast any skater in any role that the casting committee feels best tells the story. Skaters may be cast as animals, flowers, stars, etc. and female skaters may be cast as male characters. Some skaters may be required to wear wigs or hairpieces, and these are non-negotiable, just like all other costume parts.

- Shine at auditions! Auditions are your time to show the casting committee your best interpretation of the music and skating skills. Wear your favorite competition or testing dress/outfit. Do your hair and makeup. UPDATE: Do NOT dress as a specific character for our show themes.
- Initial character casting will begin at the Senior/Gold level. If there are higher than usual Intermediate/Pre-Silver and above skaters projected to audition for the 2024 show, Intermediate/Pre-Silver level skaters may or may not receive a character role in the 2024 production.

SkateSafe and SafeSport

The United States Olympic Committee (USOC) created the SafeSport program to help raise awareness about misconduct in sport, to promote open dialog and to provide training and resources.

1. As a USFS sanctioned event, we use the USFS SkateSafe and SafeSport protocols to guide our decision making and policies concerning skaters, parents, volunteers, changing rooms, cell phones and other mobile recording devices, disputes, behavior and even skater check-in/check-out procedures during dress rehearsals and performances.

2. US Figure Skating will not tolerate or condone any form of harassment or abuse of any of its members including athletes, coaches, parents, volunteers, and other persons while participating in any event conducted under the auspices of US Figure Skating.

3. Showtime on Ice is committed to creating a safe and positive environment for members' physical, emotional, and social development and ensuring that it promotes an environment free of misconduct.

4. Showtime on Ice expects that skaters, parents/guardians/volunteers, directors, show committee members, coaches, and all involved with the 2024 production comply with this protocol.

Code of Conduct

Skaters and parents/guardians must recognize that participation in all the activities associated with U.S. Figure Skating and Showtime on Ice is an honor and privilege that carries certain responsibilities. They must agree to fully abide by the rules and guidelines set forth by U.S. Figure Skating and Showtime on Ice or its properly designated agents.

Behavior and Respect

- At all times, Showtime on Ice skaters and parents/guardians are expected to show respect for himself/herself, other skaters, show directors, show choreographers, show junior choreographers, staff coaches, Showtime on Ice Committee members, show volunteer leaders and rink management personnel.
- Complete cooperation and appropriate behavior are expected during all rehearsals and performances. This includes:
 - Compliance of all rules and SafeSport guidelines posted in locker rooms.
 - Compliance of all backstage rules including, but not limited to; no jumping, spinning, or practicing backstage during rehearsals or performances, misuse or mishandling of props during rehearsals or backstage during performances.
- Skaters and parents/guardians are expected to abide by all club, rink and USFS SafeSport policies during all Showtime on Ice activities - auditions, practices, rehearsals, etc. For specific club policies, please see Code of Conduct/SafeSport protocol from DCFSC as well as US Figure Skating.

Social Media

We understand that all our skaters are connected on social media and we encourage this camaraderie at the rink. However, we will not tolerate misuse of social media of any kind. This includes and is not limited to:

- Mocking, derogatory, mean-spirited and/or bullying posts of any kind that reference Showtime on Ice, its cast, choreographers, directors, volunteers and any other person or entity involved with the show.
- Posted photos that are taken in locker rooms or any other area of the rink that is deemed off-limits per SafeSport.

We ask that all skaters adhere to these policies and use social media to spread excitement about the show and post fun and positive photos of their fellow cast members. Safety on and off the ice is a major concern. Skaters are expected (no exceptions) to follow cues and their set choreography. At various times, there may be small groups and soloists on the ice. The timing of this detailed choreography is carefully designed with safety and show appeal in mind. It is imperative that skaters pay attention to activity going on all around them during rehearsals and performances. Non-compliance will not be tolerated.

Rehearsal Protocol and Attendance

- Rehearsals will start and end on time. Skaters are expected to be prompt. Arriving early is highly recommended.
- Gum, popcorn, and candy are not allowed on the ice or at the barriers during rehearsals.
- Skaters must be respectful during rehearsals. Excessive talking or fooling around will not be tolerated and will be subject to disciplinary action.
- Skaters must wear their hair secured back and off the face. If a skater is wearing hair down due to a character interpretation (designated by costume committee), the skater is expected to rehearse with the same performance hairstyle. This applies to wigs as well.
- Everyone will treat the props carefully and follow all directions and rules stated by the Prop Manager.
- Skaters must perform the elements choreographed in their number including all double jumps at every rehearsal, unless instructed otherwise. If the skater falls consistently on a designated jump during rehearsals, the skater will be instructed to replace it with a jump that can be consistently landed.
- Rehearsal attire will consist of skating clothes, not jeans.
- There may be time spent standing around and waiting during a rehearsal. Skaters are expected to dress warm and always pay attention to coaches and choreography/activity going on around you. Safety is of the utmost concern.
- Skaters are expected to know the rehearsal schedule well in advance and arrange rides, if needed, to attend rehearsals. Repeated missed attendance will not be allowed.

Only skaters cast in the show may be on the ice during and around rehearsal times unless given permission by a director or show committee member.

Disregard of the Code of Conduct may result in the skater being asked to observe rehearsal from a hockey box or some other appropriate action. This will be left to the discretion of the directors/choreographers and/or Showtime on Ice committee member(s). Repeat code of conduct violations or severe one-time violations will result in the expulsion of a skater(s) from the show. Code of Conduct violations by parents and/or guardians will also incur consequences including, but not limited to, a ban from attending rehearsals, SafeSport reporting and/or expulsion from the show.

Volunteer Policy

Showtime on Ice is a non-profit event, produced by Denver Colorado Figure Skating Club. The show is organized by dedicated and appointed volunteer Committee Chairs. The event is run almost entirely by volunteers. Very soon you will be asked to sign up and assist with a wide array of volunteer tasks. Training is given for every task and participation from every family is expected. Without the help and dedication of volunteer families, there would be no Showtime on Ice! Volunteering for the show is fun and rewarding.

- Each family will be asked to give *eight hours* of volunteer service to the show.
- High school students may receive volunteer credit towards their graduation requirement by assisting with the show.
- Whether this is your first year or your tenth, all families are expected to volunteer. We will give a lot of guidance and suggestions to first time families. Everyone is valued and appreciated!
- Showtime on Ice appoints two Volunteer Coordinators. Their sole task is to help each family find a good fit based on time and talent. They will be readily accessible to answer questions and help. Please treat our knowledgeable coordinators with the utmost respect. This is a monumental job!
- If you are unable to volunteer, you may add a waiver fee of \$150 to help SOI fill those jobs that require SafeSport certification and background checks. Please note that this is a strictly SOI policy and does not fulfill the volunteer requirement for DCFSC.
- All SafeSport policies apply to every show volunteer. Please show respect for all show policies and leaders.
- USFSA has updated its policies and we will be requiring that all volunteer positions that are positions of authority and/or work one-on-one with skaters have SafeSport training and background checks.

Costumes

Costumes are created to portray a character or group of skaters. These groups and characters, combined with specific choreography, tell a specific story on ice. Please read the items below carefully. Understanding these statements helps keep costumes fees lower.

- Costumes are not designed to serve the purpose/function of a competition dress/ outfit.
- Costumes are ordered with the vision of dedicated seamstresses, show directors and specific Showtime on Ice committee members.
- Costumes are to be worn as directed by the costume committee.
- Costume parts cannot be replaced. Please keep track of all items at home, at dress rehearsals and during performances.
- Skaters are required to attend costume fittings as announced.
- Costumes will be fitted but are not meant to be worn with the same seamless/custom fit as dresses/outfits worn for competitions.
- Costumes are meant to last for dress rehearsals and show performances. Any life given to costumes after the show is a bonus!
- Costumes may not be altered in any manner unless approved by the costume committee chair. This includes but is not limited to; the addition of crystals, other stones, accessories or any other embellishments.
- In order to ensure everyone's health and safety on Audition Day, we have a self-measurement procedure for costume measurements prior to registration close on October 21, 2023. All measurements will be entered during the skater registration process. However, if you are not comfortable with the measurements you have taken, we will have costume volunteers available to verify them on Audition Day. (More information regarding this will be communicated prior to Auditions.) You will find all the information and measurement instructions under the Costume sections on the website.

Important Dates

Please check these dates carefully. Attendance and adherence to these dates are critical to the success of the show. Also, we know from years and years of producing the show, the skater's experience is greatly enhanced when making every possible effort to attend each of these events.

September 22, 2023 – Registration Opens

October 21, 2023 – Registration Closes (or as soon as we reach 200 total and 100 LTS registrations)

October 26-27, 2023 – Last USFS test session for 2023 casting consideration. (Free Skate Levels Only)

October 28, 2023 – AUDITION DAY (South Suburban Sports Complex) January 15, 2024 – Final Balances Due (Invoices will be sent 12/15/23) January 20, 2024 – Cast Photo Day (photos taken for show program) at SSSC February 10, 2024 – Costume Fitting Day (main fitting date) at SSSC March 7 – 10, 2024 (Denver Invitational) – Last test date and results due for Stars of the Show (including virtual tests) March 23 – April 18, 2024 - Showtime on Ice Rehearsals (this represents a range of dates specific groups or individual characters will attend as directed by a specific rehearsal

schedule*)

April 17 & 18, 2024 – Dress Rehearsals April 19-21, 2024 – Show Performances**

* The show standard format: those in the first half of the show only, plan to rehearse each Saturday or Sunday over the March/April dates listed above - basically, four Saturdays or four Sundays. You will not know whether it is a Saturday or Sunday until after Casting and after the rehearsal schedule has been made. Rehearsal schedule comes out after the first of the new year.

For those in both halves of the show, rehearsals will be Saturday or Sundays typically and then either Tuesday or Thursday nights. Again, all rehearsals occur during the time frame of **March 23– April 18**, **2024**. Everyone will need to block out evenings the week of the show - **April 15-21**, **2024** - for rehearsals, dress rehearsals and performances.

** We have four performances over three days. There is an evening performance on **Friday** (4/19); there is a matinee performance and an evening performance on **Saturday** (4/20); and there is one matinee performance on **Sunday** (4/21).

Frequently Asked Questions

What is Showtime on Ice?

The late Peggy DeLio created the show experience to expose figure skaters and their families to Broadway musicals and classics. The first show was modeled after Ice Follies and every year, the show has had a different theme.

Where/When is the event held?

The event is held at South Suburban Sports Complex – April 19-21, 2024. Four performances are held over three consecutive days. There are two evening performances and two matinee performances.

Are there auditions?

Skaters will attend an audition on October 28, 2023. They will be cast as a specific character or member of a skating group. Our Casting Criteria is posted on the bulletin boards at South Suburban Sports Complex, Family Sports Center and show website.

When are the rehearsals/what is the time commitment?

Rehearsals begin on March 23, 2024 and run right up to opening night! Rehearsal times are dependent on your skater's level. The rehearsals usually run for an hour or so on Saturdays or Sundays and possibly one-week night. The week before the show, we rehearse every night. We typically suggest setting aside the weeks of April through the actual show to plan for rehearsals.

Do I have to have a certain skating level or ability?

During a normal season, all levels are welcome to participate. Please remember that Showtime on Ice has a place and part for all levels of skaters! We enter our planning process with this idea in mind and will do everything possible to continue to promote show's accessibility to skaters of all ages and levels. This is a great opportunity for your skater to build new relationships in the skating community, learn what it takes to be a member in a large-scale production and get some extra skating practice!

If I missed the registration deadline and the auditions, could I still sign up to participate before show rehearsals begin?

Unfortunately, not after the registration deadline has passed. Showtime on Ice is a large-scale production that takes a lot of preparation at every step in the process, therefore our deadlines are not flexible. We will be happy for you to join the show next year!

Showtime on Ice Mission, Casting and Eligibility Information Revised August, 2023 Showtime on Ice will comply with the Safe Sport requirements as set forth by US Figure Skating.

MISSION: To produce a financially self-sustaining amateur ice show and to provide skaters of all ages the opportunity to experience the joy of performing on ice.

COVID-19 Disclaimer: During these unprecedented times the health and safety of our skating community remains to be of utmost concern as we begin planning and producing the new season of the show. Showtime on Ice Committee reserves the right to amend the show policy regarding its format, the number of participants and the casting process in order to comply with all Federal, State, and Local regulations and any additional public health notices in place for 2023-2024. Any changes not stated in this document will be advanced to all registered show participants later in the process via email and pre-event announcements.

ROLE OF THE ICE SHOW COMMITTEE CHAIRS

- 1. All Show Committee Members will work as a team to facilitate the production.
- 2. All Show Committee Members' decisions will be made in the best interest of the production.
- 3. All Show Committee Members will leave any personal agendas outside of the meetings.
- 4. All Show Committee discussions and decisions will be strictly confidential.
- 5. All Show Committee discussions will be supported publicly by all members of the committee.
- 6. All Show Committee members who have children participating in the production will be excused from casting discussions whenever their child is under consideration for a role.
- 7. All Committee Members will uphold and enforce the rules, requirements and regulations as set forth by US Figure Skating.

CRITERIA FOR THEME SELECTION

- 1. The number of skaters necessary for casting featured roles will be considered.
- 2. The acting abilities of those skaters available to participate in the show, attend rehearsals, along with their test levels and placement at qualifying competitions will be considered.
- 3. Appropriate themes for young people and children will be considered, plus themes that appeal to a wide range of ages and audiences.
- 4. The capability to <u>successfully</u> stage a theme which is under consideration will weigh into the selection of a given theme.
- 5. The announcement for the major show theme selection will be posted within thirty-six hours after the final committee decision has been made.
- 6. No music (edited or original) will be distributed to coaches or skaters prior to auditions. However, if skaters on their own, choose to practice with show-themed music, they are encouraged to do so.

CRITERIA FOR SKATERS AND CASTING NOTES

ELIGIBILITY CRITERIA FOR SHOWTIME ON ICE

1. A skater must be a full member of DCFSC (Denver Colorado Figure Skating Club)

OR

2. A skater must be an associate member of DCFSC (Denver Colorado Figure Skating Club) AND

- Most of the skaters' training time must be at South Suburban Sports Complex or Family Sports Center.

- The associate members of DCFSC who train at another facility must be working with a South Suburban Sports Complex/Family Sports Center staff coach in the head coach capacity. 3. A skater may be a Learn to Skate participant AND

- The skater must train (take classes/private lessons) at South Suburban Sports Complex or Family Sports Center most of their time.

4. All skaters must be registered by the registration deadline and attend auditions in order to be eligible to participate in the show. No late registrations will be accepted after registration closes on October 21, 2023.

5. All adult skaters must be registered by the registration deadline. Adult skaters are not required to attend auditions. No late registrations will be accepted after registration closes on October 21, 2023.

CASTING CRITERIA FOR SHOWTIME ON ICE – Showtime on Ice reserves the right to cast any skater in any role that the casting committee feels best tells the story. Showtime on Ice does not and shall not discriminate on the basis of gender, gender expression, race, color, religion, or national origin, in any of its activities including casting roles.

1. A skater's test level(s) will be considered.

a. The cut-off for testing must be posted by SOI Committee at South Suburban Sports Complex and Family Sports Center, two (2) months prior to the first audition date. The cut-off date for testing for the 2024 production is October 26 & 27, 2023. Only highest, passed singles/freestyle USFS levels are considered. Moves in the field levels are not considered for casting purposes.

b. <u>Due to the increased number of Pre-Silver/Intermediate and above</u> <u>skaters expected to audition for the 2024 production, named characters</u> <u>are not guaranteed for Pre-Silver/Intermediate and below skating levels.</u>

c. If a skater chooses to test at another facility or virtually, the above deadline for testing date stands as the cut-off.

d. A skater will be cast at the singles/freeskate level they have achieved at the time of auditions. Dance equivalency to singles/freeskate levels is posted and has been determined by Showtime on Ice, a USFS judge and appropriate dance instructors. The dance to singles/freeskate equivalency chart is not a USFS chart but has been determined as the best representation of skill equivalency for casting purposes.

e. Information concerning the Stars of the Show number/qualifications is outlined on the last page of this document.

- 2. A skater's placement(s) at U.S. Figure Skating qualifying competitions, specifically Regionals, Sectionals, Nationals, for all disciplines will be considered during casting. Placement at any qualifying event does not guarantee a step-out or lead role.
 - a. If a skater participates in **NQS** (*qualifying*) events -the results may be considered but are not required as a factor for casting as deemed by the SOI casting committee.
 - b. If a skater at National Showcase wins their final round and advances to the Parade of Champions, they will be considered during casting, but this does not guarantee a step-out or lead role.
 - c. If a skater places first at **Solo Dance Qualifying Series**, they will be considered during casting, but this does not guarantee a step-out or lead role.
- 3. Auditions will determine abilities for acting/character roles. Auditions are mandatory, unless a skater has an excused absence, injury or has made prior arrangements with the SOI Directors and a Committee member.
- 4. A skater's age, height and skating ability and rehearsal availability will be taken into consideration and at the discretion of the casting committee.
- 5. Adult skaters who are partnered with underage skaters, per US Figure Skating SkateSafe and SafeSport requirements, are now required to complete a background check. Showtime on Ice will cover costs for all background checks deemed necessary because of casting.
- 6. Showtime on Ice may invite guest skaters.

CASTING NOTES/EXPECTATIONS

- If a skater is assigned a leading role in the first half of the show, then a group number is assigned in the second half of the show. If a skater is assigned a leading role in the second half of the show, then a group number is assigned in the first half of the show. The show committee has the right to determine the needs of the show and to decide which half of the show the skaters will be assigned.
- 2. A commitment by the skater to attend rehearsals for both leading parts and group numbers is required. If the skater must miss a rehearsal, it shall be communicated to SOI Performance Director in advance and excused.

STARS OF THE SHOW

- UPDATED FOR 2024 DUE TO NEW USFS RULES

The tradition of the opening number, Stars of the Show, is important and valued. It is reserved for our highest level skaters as outlined below. If the number of skaters who have met the criteria for a step-out in the number becomes too large in any given year, the Showtime on Ice Committee in conjunction with the directors (Performance, Choreography and Theatrical) reserve the right to alter the format of the step-out as needed.

 In recent years, skaters at the Pre-Silver/Intermediate test level and above in FS/Pairs or all the Pre- Silver compulsory pattern dances have been included in the opening show number, Stars of the Show. <u>However,</u> <u>depending on the number of skaters at this level, Stars of the Show</u> <u>criteria may revert to Silver/Novice and above skaters, as in the past.</u>

a. <u>Skaters will be cast in Stars of the Show based on the level they are at</u> <u>auditions. After our audition/casting date we will NOT move skaters from</u> <u>lower levels into the Stars of the Show number, as we have in the past.</u>

b. Pair skaters who wish to participate in Stars of the Show number must have a pair partner.

2. Skaters at the Silver/Novice test level in FS/Pairs or all the Silver compulsory pattern dances have met the criteria for a step-out role in the Stars of the Show number.

a. Skaters that have not tested and passed the Silver/Novice test level in FS/Pairs or all the Silver compulsory pattern dances must do so by the March 2024 test date or at Denver Invitational. This test date is offered by DCFSC. A test may be taken and passed at another facility or virtually, but it may not occur later than the designated test date for DCFSC and/or Denver Invitational, March 2024.

Should you have any questions concerning casting, Stars of the Show, or step-outs, please contact a Showtime on Ice committee member well in advance of auditions and/or testing deadlines.

Please note that a separate skating dress is required for the Stars of the Show number and needs to be provided by the skater – not our costume team.

WAIVERS

Please read through ALL the following waivers. You will need to agree to these when you complete the registration form.

Payment is collected by PayPal online. Payment may be accepted by personal check if arrangements have been made with our show treasurer PRIOR to Audition Day (October 28, 2023).

If the Show is canceled PRIOR to Audition Day (October 28, 2023) – 100% of the show deposit will be refunded.

If the show is canceled AFTER Audition Day (after October 28, 2023) – 50% of the show deposit will be refunded. This is because casting takes place immediately after Audition Day and costume order is placed promptly after that date.

A portion of the deposit money is used for marketing, setting up facility contracts, and paying director fees. If the Show is canceled any time after November 11, 2023 – 20% of show registration fees will be refunded.

SkateSafe, SafeSport and USFS waiver and acknowledgement:

I agree that I/my skater will abide by all expectations set forth by the governing body of USFS, the USFS SkateSafe and the SafeSport organization.

I acknowledge that if I am currently, or will be, the age of 18 during any part of the show season; I will need to complete the necessary background check and SafeSport certification course. The certification course is free, and the background check is a nominal fee.
